**RESOLUTION TO APPROVE THE APPOINTMENT OF  
WALLY M. SEDLAR AS COUNTY CONSERVATIONIST**

**INTRODUCED BY:** Executive Committee

**INTENT & SYNOPSIS:** To appoint Mr. Wally M. Sedlar to the position of County Conservationist for Adams County at an annual salary of \$67,081.

**FISCAL NOTE:** None, monies are budgeted for the position in the Department's 2013 budget.

**WHEREAS:** On October 7, 2013, the Executive Committee and members of the Land & Water Conservation Committee conducted interviews for the position of County Conservationist. The Committee selected a final candidate; and

**WHEREAS:** The Executive Committee approved for the Personnel Director to make an offer; and

**WHEREAS:** The Executive Committee approved the terms of Walter M. Sedlar's employment offer and recommended adoption by the County Board; and

**WHEREAS:** Mr. Sedlar would start working limited hours at \$32.25 per hour effective immediately, and become a full-time employee on approximately December 16, 2013, with an annual salary of \$67,081;

**NOW THEREFORE, BE IT RESOLVED:** By the Adams County Board of Supervisors that it is hereby approved to appoint Mr. Wally M. Sedlar to the position of County Conservationist with an annual salary of \$67,081.
